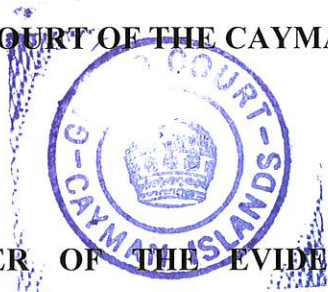

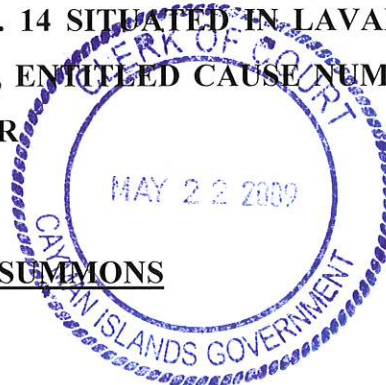

EX PARTE ORIGINATING SUMMONS


LET ALL PARTIES concerned attend before the Judge in Chambers at the Law Courts, George Town, Grand Cayman on the day of 2009 at o'clock in the forenoon upon an application by the Attorney General for the following orders that:

1. The Custodian of the Records of BANCO COMAFI, CAYMAN LTD, George Town, Grand Cayman, Cayman Islands, do appear at such place, date and time as the Clerk of Courts shall appoint and there give evidence and produce to the Clerk of Courts the documents set out in Schedule attached hereto.
2. That the said Custodian of the Records do apply to the Grand Court pursuant to section 4 of the Confidential Relationships (Preservation) Law for directions as to

the manner of producing the documents within 7 days of the service of any order of this Honourable Court therein.

3. That the Clerk of Courts do receive evidence and cause the deposition of evidence and all documents produced by the said Custodian to be filed in the Registry of the Grand Court and do forward the said documents to The Embassy of the Argentine Republic, 65 Brook Street, London, W1Y 4 AH., England for onward transmission to the Oral Criminal Court #14 situated in Lavalle, Buenos Aires, Republic of Argentina.
4. Such other orders and directions as this Honourable Court deems fit.
