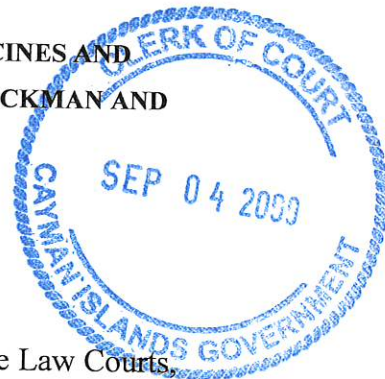

EX PARTE ORIGINATING SUMMONS

LET ALL PARTIES concerned attend before the Judge in Chambers at the Law Courts,
George Town, Grand Cayman on the day of 2009 at o'clock in the
forenoon upon an application by the Attorney General for the following orders that:

1. The Clerk of Courts do issue a subpoena for the Custodian of the Records of Cayman National Bank, PO Box 1097, Grand Cayman KY1-1102 to appear before him at such date place and time as he shall appoint.
2. The Custodian of the Records of Cayman National Bank do appear at such place, date and time as the Clerk of Courts shall appoint and there produce to the Clerk of Courts all information held by the Cayman National Bank in relation to account number 042 00379 in the name of Hobbit International; when this account and any related accounts were opened; the names and personal contact details of authorised signatories to the account and any related accounts; statements for the account and any related accounts for six years, or since the account was opened, whichever is less; and details of all transactions between the account and account 40012831706, Bank of Valetta, Malta.



3. The Clerk of Courts do issue a subpoena for the Custodian of the Records of Hobbit International, PO Box 1111GT, 4th Floor, West Wind Building, Harbour Drive, Grand Cayman to appear before him at such date place and time as he shall appoint.
4. The Custodian of the Records of Hobbit International, do appear at such place, date and time as the Clerk of Courts shall appoint and there produce to the Clerk of Courts all documentation relating to Hobbit International, and in particular, any documentation regarding the relationship between Hobbit International, Martin Simon Hickman, Jodie Shawcross, MSH Word Traders Limited (UK) and MSH World Traders Limited (Malta), also known as Livingwell Limited; documentation regarding the circumstances in which Hobbit International was appointed director of MSH World Traders Limited (Malta) in 2004; the activities of Hobbit International as director of MSH World Traders Limited (Malta), and; the financial relationship between MSH World Traders Limited (Malta) and Hobbit International, including the source, purposes, destination and current location of all funds transferred from MSH World Traders Limited (Malta) to Hobbit International.
5. The Clerk of Courts cause all documents produced by the said Custodians to be filed in the Registry of the Grand Court and do send them, together with this Order, the request and all documents produced by the said Custodians to Ms Marguerite Hutton-Wilson, Office of the Solicitor, The Department of Work and Pensions, The Department of Health, Prosecutions Division, New Court, 48 Narey Street, London, WC2A 2LS, United Kingdom.
6. That the said Custodian of the Records of Cayman National Bank do apply to the Grand Court pursuant to section 4 of the Confidential Relationships (Preservation) Law for directions as to the manner of producing the documents within 7 days of the service of any order of this Honourable Court therein.

7. Such other orders and directions as this Honourable Court deems fit.
