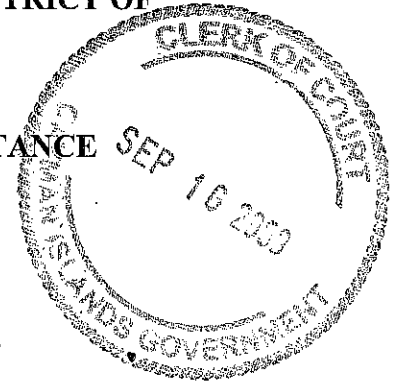

EX PARTE ORIGINATING SUMMONS

Jacqui Powell-Marsden, Custodian of the Records for Caledonian Bank Limited, Box 1043 Caledonian House, 69 Dr. Roy's Drive, George Town, Grand Cayman, Agent Bank for Bancolombia Cayman to appear at such place, date and time as the Clerk of Courts shall appoint to be examined upon oath by the said Clerk of Courts in relation to the matters set out in the schedule hereto.
2. That the Clerk of Court do record and transcribe the evidence of the said Jacqui Powell-Marsden.
3. That the Clerk of Courts do file the abovementioned transcript of the evidence of Jacqui Powell-Marsden in the Registry of the Grand Court and do receive any documents produced by the said Jacqui Powell-Marsden and do forward the said

transcript together with all documents received to the Court of the Judicial District of Bogota , Republic of Colombia.

4. Such other orders and directions as this Honourable Court deems fit.

2. The type of currency applicable to the aforesaid Time Deposit Certificate?
3. The legal force of any ruling made by a Family Court Judge in Colombia in proceedings in relation to the said Certificate on the Bancolombia Cayman?
4. The procedure to be followed to collect such Certificate by those interested in this inheritance?
5. The tax and/or cost that such collection would accrue?
6. Whether there are beneficiaries mentioned in the said Certificate and if there are their names?
7. Whether with the proceeds of Time Deposit Certificate No. 022105710 or any part thereof Time Deposit Certificate No. 22109332 was opened under the name of Mrs. Talia Carolina Osorio Cardona?
