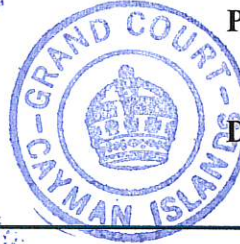

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

PARTICULARS OF CLAIM

1. The Plaintiff is a company duly incorporated and domiciled in the Cayman Islands.
2. The Plaintiff loaned the sum of CI\$65,600.00 (the "Principal") to the Defendant.
3. The Defendant signed a promissory note on the 17th March 2008 in the Plaintiff's favour for the Principal sum (the "Promissory Note"), the same being attached to these Particulars of Claim.
4. The Plaintiff made a written demand of the Defendant for the repayment of the Principal in full on the 23rd March 2009.
5. The Defendant has failed to repay the Principal or any part of it, notwithstanding the Plaintiff's demand letter of 23rd March 2009.
6. The Defendant is liable in respect of interest on the Principal pursuant to Section 34 (1) Judicature Law (2007 Revision) in the amount of CI\$1,617.53 and continuing from the date hereof at the rate of CI\$8.99 per day until payment.

STATEMENT REGARDING INTEREST


7. The rate of Pre-judgment interest from 23rd March 2009 to 18th September 2009 (180 days) is CI\$1,617.53 at 5 % per annum.
8. The total amount of interest claimed is CI\$1,617.53
9. The interest accruing each day hereafter is CI\$8.99

AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANT:

1. The sum of CI\$65,600.00;
2. Interest pursuant to section 34 (1) Judicature Law (2007 Revision);
