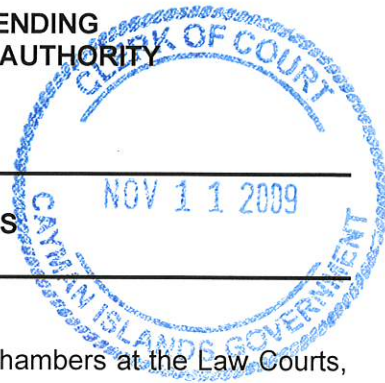

LET ALL PARTIES CONCERNED attend before the Judge in Chambers at the Law Courts, George Town, Grand Cayman on the day of , 2009 at on the hearing of an application by the Cayman National Bank for directions pursuant to Section 4 of the above-mentioned Law.

The Applicant is required by an Order of the Grand Court dated 22 October 2009 (served on the Applicant on 4 November 2009) in Cause No 0421 of 2009 and a pending subpoena to appear at such place, date and time as the Clerk of Courts shall appoint and there produce to the Clerk of Courts as evidence in connection with the above-mentioned Proceedings before the City of Westminster Magistrates Court, England, United Kingdom, confidential information held by the Applicant in relation to account number 042 00379 in the name of Hobbit International; when this account and any related accounts were opened; the names and personal contact details of authorised signatories to the account and any related accounts; statements for the account and any related accounts for six years, or since the account was opened, whichever is less; and details of all transactions between the account and account 40012831706, Bank of Valetta, Malta, and seeks:-

1. An Order that this Ex Parte Originating Summons be heard, and determined, on an expedited basis;

2. A Direction that the Applicant disclose in writing to the Clerk of Courts: the date on which account number 042 00379 in the name of Hobbit International and any related accounts were opened; the names and personal contact details of authorised signatories to the account and any related accounts; statements for the account and any related accounts for six years, or since the account was opened, whichever is less; and details of all transactions between the account and account 40012831706, Bank of Valetta, Malta; and
3. Such other or further Orders or Directions as this Honourable Court deems necessary.
