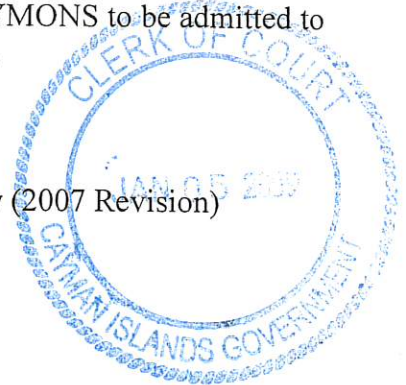
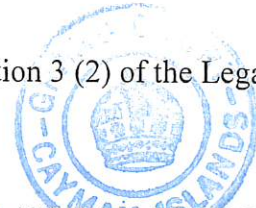


AFFIDAVIT

1. I attended the Cayman Islands Law School and obtained a Bachelor of Laws with Honours on 4 July 2003. Exhibited hereto and marked "SPS-1" is a true copy of my Degree of Bachelor of Laws of the University of Liverpool.
2. Upon completion of my Bachelor of Laws I undertook the Graduate Diploma in Legal Practice ('GLDP') a Practical Legal Training course at the University of Western Sydney in the State of New South Wales, Australia.
3. The GDLP contains a required element of Practical Legal Training ('PLT') Placement. I undertook my PLT Placement from about 9 May 2006 to 25 August 2006 with the Law Firm of David Kam & Co, Solicitors ('David Kam & Co') located in Sydney in the State of New South Wales, Australia.
4. In about late September 2006 I received a letter from the University of Western Sydney dated 28 September 2006 stating that my logbook for placement undertaken at David Kam & Co was approved by the Professional Work Experience Committee. 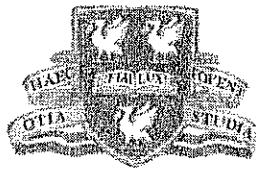



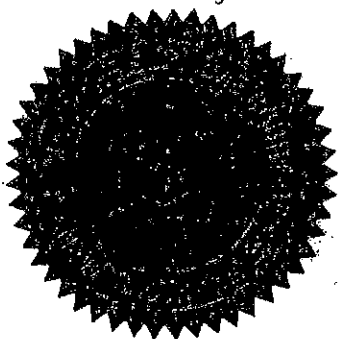
