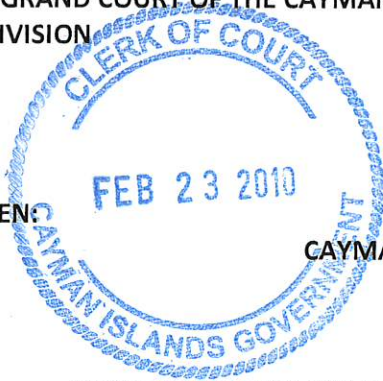

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within [14 days] after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service, stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

STATEMENT OF CLAIM

1. The Plaintiff is a company who at all relevant times was lawfully trading in the Cayman Islands as a limited liability company.
2. On various dates between the 4th December 2007 and the 16th December 2008 the Plaintiff and the Defendant contracted for the provision of advertising for the Defendant within the Plaintiff's publications.
3. The Defendant agreed to pay the total sum of C\$52,216.92 for the advertising services provided by the Plaintiff.
4. In breach of the said advertising agreement the Defendant has failed or neglected to pay for the advertising services provided.
5. The Plaintiff provided invoices detailing the charges incurred by the Plaintiff and annexes the summary of these to the Statement of Claim marked Schedule 1 displaying the dates of all advertising provided and the charges incurred therein.
6. The Plaintiff claims for monies due and owing on foot of the agreements and interest on the monies owing.

STATEMENT REGARDING INTEREST

a)The Plaintiff seeks pre and post judgment interest from the date of issue of the Plaintiff in accordance with the Judicature Law (2007 Revision) and the Judgment Debt (Rates of Interest) Rules as amended from time to time.

b)The interest rate as per the Judgment Debt (Rates of Interest) Rules is 5% per annum.

c) The date from which interest is calculated is 16th December 2008.

d) The total amount of interest claimed as at 23rd February 2010 is CI\$3,089.89.

e) The amount of interest accruing each day following the issue of this Plaintiff is CI\$7.15.

AND THE PLAINTIFF CLAIMS:

- (i) The said sum of CI\$52,216.92.
- (ii) Interest on the said sum of CI\$3,089.89 pursuant to the Judicature Law (2007 Revision) with interest accruing at the rate of CI\$7.15 per day until satisfaction of the debt.
- (ii) Fixed costs of CI\$150.00, alternatively costs to be assessed plus filing fees.

If, within the time for returning the Acknowledgement of Service, the Defendant pays the total amount claimed of \$52,216.92 (including filing fees of CI\$200 and ad valorem filing costs of CI\$422.16 and interest of CI\$3,089.89) and costs to be taxed if not agreed and bailiffs fees further proceedings will be stayed. The money must be paid to the Plaintiff or his Attorney.
