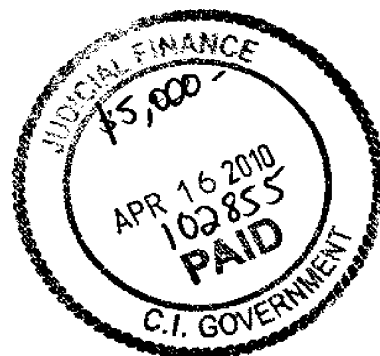

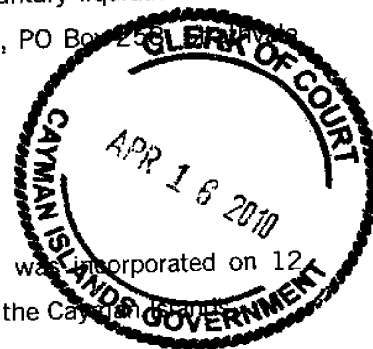


WINDING UP PETITION
