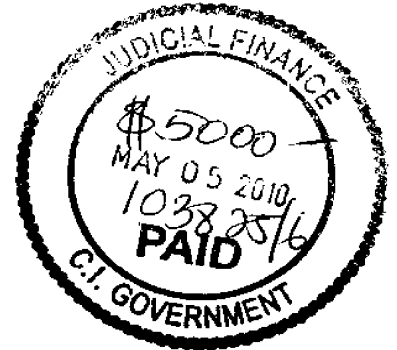

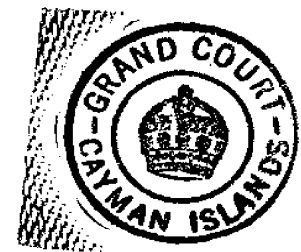

By this Summons, which is issued on the application of the First Plaintiff RBC Trust Company (Jersey) Limited of La Motte Chambers, St Helier, Jersey, Channel Islands JE1 1PB, the Trustee of the above-mentioned RRS Edgar No 1 Settlement and RRS Edgar No 2 Settlement, and the Second Plaintiff, Regent Capital Trust Corporation Limited of La Motte Chambers, St Helier, Jersey, Channel Islands JE1 1PB, the Trustee of the above-mentioned RRS Edgar No 3 Settlement and RRS Edgar No 4 Settlement, the Plaintiffs seek the following relief and/or directions, namely:

1. That the RRS Edgar No 3 Settlement be rectified:
 - (1) by substituting for clause 1.6.1 thereof, the following:

"The children and descendants of Mr Edgar born before the expiration of the Trust Period."
 - (2) by deleting clause 1.6.2 thereof.
2. Alternatively to paragraph 1 above, that the transfer of assets from the RRS Edgar No 1 Settlement to the RRS Edgar No 3 Settlement effected by Deed dated 15 January 2002 be declared void or, alternatively, set aside.
3. That the RRS Edgar No 4 Settlement be rectified by adding a new paragraph, clause 1.6.5, as follows:

"Sarah Edgar the wife of the late Mr. Anthony Edgar"
4. Alternatively to paragraph 3 above, that the transfer of assets from the RRS Edgar No 2 to RRS Edgar No 4 effected by Deed dated 15 January 2002 be declared void or alternatively, set aside.
5. All necessary representation orders
6. Further or other relief and/or directions
7. That provision be made for the costs of this application

If any Defendant does not acknowledge service, such judgment may be given or order made against or in relation to him as the Court may think just and expedient.
