THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495, Grand Cayman, KY1-1106 the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

STATEMENT OF CLAIM


1. The Plaintiff is and was at all times an ordinary resident company carrying on the business of home décor and construction material suppliers in the Cayman Islands with its registered office located at [], George Town, Grand Cayman. For the purpose of this proceeding its address for service is in care of its attorneys, Appleby, of P.O. Box 190, Grand Cayman, KY1-1104, Cayman Islands.
2. The First Defendant is an ordinary resident company operating in the Cayman Islands with a mailing address of PO Box 294, Grand Cayman KY1-1104. At all material times the Defendant was a customer of the Plaintiff.
3. The Second, Third and Fourth Defendants are individuals who reside in the Cayman Islands with a mailing address in care of PO Box 294, Grand Cayman KY1-1104 Cayman Islands. At all material times the Second, Third and Fourth Defendants (together with the First Defendant (the "Defendants") were customers of the Plaintiff.
4. On or about 8 January 2009 the First Defendant entered into a credit agreement with the Plaintiff for a monthly line of credit of CI\$30,000.00 (the "Credit Agreement"). The Credit Agreement included the following terms:
 - a. The Plaintiff would advance goods on credit to the Defendant;
 - b. The First Defendant shall pay to the Plaintiff the full amount of any and all purchases charged to the Defendant's account and billed not later than 30 days after the date of rendering of the Plaintiff's statement of account;
 - c. Interest shall accrue on any unpaid billed sum or sums following 30 days from the statement date. Interest shall be calculated commencing 30 days after invoice date at the simple rate of 2% per month (calculated daily);

- d. The First Defendant would pay on an indemnity basis all legal costs and disbursements incurred by the Plaintiff resulting from or following a default of the Company on payment of any one or more bills;
 - e. The Plaintiff would charge CI\$35, excluding Bank fees, for each check returned for non sufficient funds;
 - f. Employees of the First Defendant would be authorised to charge items to the First Defendant unless otherwise specified to the Plaintiff and agreed to by the Plaintiff;
 - g. The credit privileges can be cancelled at any time by the Plaintiff without notice and in any event if the account becomes in default or credit limits are exceeded; and
 - h. Objections to invoices and settlements for materials supplied must be submitted in writing within two weeks of the date of such invoices and statements and thereafter shall be deemed approved.
5. The Plaintiff advanced credit to the First Defendant from time to time in accordance with the terms of the Credit Agreement.
 6. The First Defendant did default on the terms of payment and as of the date of the commencement of this proceeding, 2 July 2010, the Defendant owed to the Plaintiff the sum of CI\$25,075.21 plus interest of CI\$2,076.29. Interest continues to accrue under the Credit Agreement at the rate of CI\$16.49 per day from 3 July 2010.
 7. The Second, Third and Fourth Defendants personally guaranteed payment in full of the charges incurred by the First Defendant pursuant to the Credit Agreement by signing a Personal Guarantee. A term of the Personal Guarantee was, *inter alia*, that the Second, Third and Fourth Defendants shall be liable to the Plaintiff for all monies due to the Plaintiff by the First Defendant.

8. Notwithstanding demands for payment by the Plaintiff, the First Defendant and a demand on the Second, Third and Fourth Defendants as guarantors, the Defendants have either failed or neglected to make payment to the Plaintiff in respect of indebtedness under the Credit Agreement.
9. Further and/or in the alternative, the Defendants ordered goods from the Plaintiff with a value totalling CI\$25,075.21 and the Plaintiff supplied the goods to the Defendants. To date, the Defendants have failed or neglected to make payment in this amount to the Plaintiff despite demand.
10. As a result of the above, the Plaintiff is entitled to the relief claimed in this proceeding.

AND THE PLAINTIFF claims:

- a) CI\$25,075.21 being the principal sum due;
- b) CI\$2,076.29 interest to 2 July 2010 at the rate of 24% per annum in accordance with the Credit Agreement;
- c) Pre and post judgment interest calculated from 3 July 2010 at the rate of 24% per annum in accordance with the Credit Agreement;
- d) Alternatively pre and post judgment interest in accordance with the *Judicature Law (2007 Revision)* and the Judgment Debt (Rates of Interest) Rules as amended from time to time;
- e) Costs on an indemnity basis, in accordance with the terms of the Credit Agreement;
- f) Alternatively, costs on an indemnity basis or standard basis in accordance with the Court Costs Rules 2001; and
- g) Such further and other relief as this Court may deem just.

INDORSEMENT

The principal amount claimed in respect of the debt is CI\$25,075.21 plus interest of CI\$2,076.29 as of the date of filing. The amount of the filing fees to commence the proceeding is CI\$200.00, plus ad valorem fees of CI\$150.75. If, within the time for returning the acknowledgement of service, the Defendants pay the Plaintiff or its attorneys-at-law the total amount claimed in principal plus interest and costs to the date of payment, further proceedings will be stayed. The money must be paid to the Plaintiff or its attorneys-at-law.

INDORSEMENT REGARDING INTEREST

1. The contractual term upon which interest is claimed is as set out in paragraph 4 (c) above;
2. the prescribed rate of interest is 24% per annum;
3. the date from which interest is payable is 22 January 2010;
4. the total interest claimed as at of 2 July 2010 is CI\$2,076.29; and
5. the amount of interest accruing due each day is CI\$16.49

**DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS**

1. The accompanying form of *Acknowledgment of Service* should be completed by an Attorney acting on behalf of each Defendant or by each Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, PO Box 495 GT, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a **FIRM** and an attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
