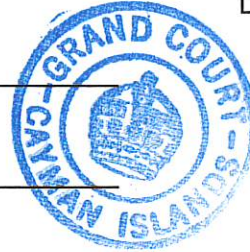

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff of 253 Lakeshore Road North, RR 1, Meaford, Ontario, N4L 1W5, CANADA in respect of the claim set out on the next page.

Within 28 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495 GT, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

NOTE – This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by Order of the Court.


**GENERAL INDORSEMENT**

---

The Plaintiff's claim is for:

1. an injunction prohibiting the Defendant, until the final determination of proceedings between the Plaintiff and the Defendant before the Superior Court of Justice, Family Court Branch, in Ontario, Canada, which have been assigned Court File Number: 11-7642, from removing from the Cayman Islands or in any way disposing of or dealing with or diminishing the value of any of his assets which are in the Cayman Islands whether in his own name or not and whether solely or jointly owned up to the value of CAD\$3.5 million, including the following assets:
  - (a) the property known as Block 27C, Parcel 555 in the Savannah Registration Section of Grand Cayman or the net sale money after payment of any mortgages or charges if it has been sold; and
  - (b) any money in the accounts numbered 022 23582 and 011 12590 at Cayman National Bank.
  
2. costs.

If, within the time limited for acknowledging service, the Defendant pays the sum of CAD\$3.5 million to the Plaintiff, further proceedings will be stayed.
