2. Pursuant to Section 4 of the CRPL, directions as to whether the Applicant shall disclose the Confidential Information to Guardian;

3. In addition or in the alternative, any directions as the Court shall think fit pursuant to Section 48 of the Trusts Law;
4. That provision be made for the costs of this application; and
5. Such further or other directions as the Court shall think fit.
