If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

To the best of the Plaintiff's knowledge and belief the first Defendant was insured by Britcay when driving on Sunday 3rd August 2008, whose address is Box 74, Britcay House, 236 Eastern Avenue, George Town, Grand Cayman

The Second Defendant was an employee of the Cayman Islands Health Services Authority, a department of the Cayman Islands Government, and to the best of the Plaintiff's personal representative's knowledge and belief the Second Defendant was insured through the third Defendant's insurers, Royal Star Ltd, Box 2174, Cayman Financial Centre, Dr Roy's Drive, KY1-1105.

GENERAL ENDORSEMENT

The Plaintiff's claim is for General and Special Damages arising as follows:

1. The Plaintiff was injured whilst acting in the course of his employment with the Health Services Authority in a road traffic incident which took place on 3 August 2008. On that date he was employed as paramedic and the ambulance in which he was travelling was driven by the Second Defendant.

2. The ambulance responded to a 911 call and was travelling towards George Town in the region of Savannah Countryside Shopping Village when a Buick motor car Registration 68286 driven by the deceased, Halstead Jackson turned into the path of the ambulance and the ambulance swerved to avoid it colliding with building. The Plaintiff was in the back of the ambulance attending to the patient and as a result of the accident he was thrown about and sustained injuries.
3. The Health Services Authority, on 1 September 2009, dismissed the Second Defendant for gross misconduct. By letter of termination the Health Services Authority indicated that the Second Defendant's "inappropriate actions in that incident also directly led to injuries to multiple parties.
4. The said accident was caused or contributed to by
 - a. the negligence of the deceased Halstead Jackson (the First Defendant) who turned into the path of the oncoming ambulance and/or
 - b. the negligence of the Second Defendant in failing to take appropriate action.
5. The Cayman Islands Government is vicariously liable for the negligence of their employee.

AND THE PLAINTIFF CLAIMS:

- (1) General and special damages for personal injury;
- (2) Interest on the said damages pursuant to section 34 of the Judicature law (2007 Revision);

(3) Costs;

(4) Further and/ or other relief.

AND the Plaintiff claims damages and interest thereon and costs.

**DIRECTIONS FOR ACKNOWLEDGEMENT OF SERVICE
OF WRIT OF SUMMONS**

1. The accompanying form of *Acknowledgement of Service* should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, PO Box 495, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgement of Service that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is endorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2). The defence must be served within fourteen (14) days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not endorsed on the Writ, the defence need not be served until fourteen (14) days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for fourteen (14) days after his Acknowledgement, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Courts Office.
2. For the purpose of calculating the period of fourteen (14) days for acknowledging service, a Writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a FIRM and an Attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
