

5. A SUBPOENA FOR BANK RECORDS BE GRANTED.

6. A RESTRAINING ORDER AGAINST THE DEFENDANT.



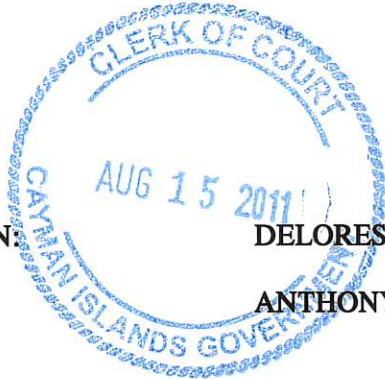

NOTICE OF APPEAL

TAKE NOTICE that I, Delores English Dawkins, intend to appeal against the order of the Summary Court made on 4 August 2011.

The grounds of my appeal are as follows:

1. That the court was presented with the incorrect facts and the Magistrate made her decision based on the wrong facts presented.
2. That based on the incorrect facts before the Court the Magistrate ordered that I pay the Respondent CI\$3,600 of which CI\$2,600.00 is the amount of the debt and CI\$1,000.00 in respect of court fees.
3. That I have paid all of the rent monies owing to the Respondent.
4. That the Magistrate did not allow me to question the Respondent and stated that "I was not asking the question properly and I was making comments instead and move on to my next question". I am not legally represented and do not understand as I was of the opinion that I had been asking the Respondent questions.
5. That the decision of the Summary Court be stayed until the determination of the appeal.
