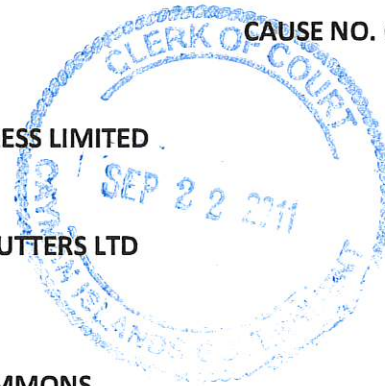

WRIT OF SUMMONS

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within [14 days] after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service, stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this day of September 2011

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

STATEMENT OF CLAIM

1. The Plaintiff is a company who at all relevant times was lawfully trading in the Cayman Islands as a limited liability company.
2. On various dates between the 27th July 2009 and the 1st January 2010 the Plaintiff and the Defendant contracted for the provision of advertising for the Defendant within the Plaintiff's publications. Such agreements were made orally between the plaintiff and the defendant and it was agreed that in consideration of the plaintiff placing advertisements for the defendant inside its publications, the defendant would pay the agreed advertising rates.
3. Pursuant to the agreements, the plaintiff placed the advertisements inside its publications between 27th July 2009 and 1st January 2010.
4. The Defendant agreed to pay the total sum of CI\$23,032 for the advertising services provided by the Plaintiff. Invoices confirming dates and amounts of the various advertising service contracts were sent by way of mail to the Defendant and a copy of the final invoice is annexed to this plaint.
5. In breach of the said advertising agreements the Defendant has failed or neglected to pay for the advertising services provided and those sums remain due and owing to the Plaintiff.
6. The Plaintiff claims for monies due and owing on foot of the agreements.
7. Particulars of Loss
The Plaintiff claims the sum of CI\$23,032 and interest upon the said sum.

STATEMENT REGARDING INTEREST

a)The Plaintiff seeks pre and post judgment interest in accordance with the Judicature Law (2007 Revision) and the Judgment Debt (Rates of Interest) Rules as amended from time to time.


1. The rate of interest claimed is 2 3/8% per annum.
2. The date from which interest is calculated is 1st February 2010, being 30 days from the last advertisement billing date. All claims for interest prior to that date are waived.
3. The total amount of interest claimed as at 14th September 2010 is CI\$882.71.
4. The amount of interest accruing each day thereafter is CI\$1.50.

AND THE PLAINTIFF CLAIMS:

- (i) The said sum of CI\$23,032.
- (ii) Interest on the said sum of CI\$882.71 pursuant to the Judicature Law (2007 Revision) with interest accruing at the rate of CI\$1.50 per day until satisfaction of the debt.
- (ii) Fixed costs of CI\$500.00, alternatively costs to be assessed plus filing fees.

If within the time for returning Acknowledgement of Service the Defendants pays to the Plaintiff's Attorneys-at-Law the total amount claimed of CI\$23,032 (together with interest of CI\$882.71, costs of CI\$500 and ad valorem fees of CI\$130.32) all further proceedings will be stayed.

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE

OF WRIT OF SUMMONS

1. The accompanying form of Acknowledgment of Service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings must also serve a defence on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A Stay of Execution against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, issue a Summons for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian ad litem.

In the case of a limited company, "residence" means its registered or principal office.
