WRIT OF SUMMONS

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within [14 days] after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

STATEMENT OF CLAIM

1. I am a community activist and former political candidate for the district of Bodden Town and have lived in the Cayman Islands community for the past 15 years as a very active member. I am also involved in a number of professional organizations and community groups as well as I am a business owner for over 7 years.
2. I had a personal relationship with Mr. Jose Luis Venner which ended in June 2011. Throughout the entire relationship Mr. Venner was extremely dishonest and apparently only sought to use me for financial gain and obtaining job security here in the Cayman Islands. I have email evidence in Mr. Venner's own words to support this statement. It appears that both he and Ms. Keisha Christian concocted a scheme for him to be able to use me to find a new job etc. and then return to her once my usefulness to him expired.
3. Mr. Venner and the other defendants named herein have undertaken a systematic defamatory attack on my character and committed both libel and slander against me.
4. Firstly, Mr. Venner claims that there were Facebook accounts created in the name of other people and started the rumor that I was behind those. He has verbally made this statement to several persons as well as posted these contentions on his Facebook wall.
5. He also indicated that a website was erected about him and again claimed that it was me that was behind it. Without any evidence whatsoever Mr. Venner proceeded to attack me online and on Facebook. He has also been going around telling numerous people that I am harassing him and trying to ruin his life.
6. Mr. Venner appears further motivated by the fact that I lodged formal complaints against all the defendants.
7. On the afternoon of September 2nd 2011 I was contacted by an associate of Mr. Jose Luis Venner who informed me that Mr. Venner (along with a local web designer Paul Dedrick) intended to put up a defamatory website about me. I proceeded to contact his employer The Security Centre and emailed Mr. Stuart Bostock about this. He noted that he would advise Mr. Venner that any such action would be against their company policy.
8. I also reported the matter to Inspector Best of the Royal Cayman Islands Police Service ("RCIPS"). Inspector Best indicated that he would attempt to contact Mr. Venner and a Mr. Paul Dedrick about the matter. Inspector Best later informed me that was not able to reach Mr. Venner. However, Mr. Dedrick had been warned not to harass me in any way shape or manner including a website publication.

9. A mutual acquaintance contacted me to indicate that Mr. Venner had put up several Facebooks posts about me shortly thereafter. See attached screenshots taken from Mr. Venner's Facebook wall. Essentially he was encouraging other people to go on a website and make defamatory comments about me. As you can see from the various postings he has gone as far as encouraging people all the way in Colombia and the Netherlands to make comments about me online.
10. Several cease and desists emails were sent directly to all 3 defendants. Mr. Venner was warned on at least 3 occasions via email and other times verbally to remove his defamatory comments about me from Facebook and any other website publication. To date he has not done so. In fact, additional postings have gone up since then.
11. Additionally Vanessa Rojas Venner has posted defamatory comments online.
12. Attempts were made to amicable put an end to all of this by seeking the assistance of the employers of each of the defendants as well as immigration and the police. These efforts were only addressed with additional attacks by all 3 defendants. The police have indicated their powers are limited but I continue to pursue that criminal route.
13. All 3 defendants have filed false police reports against me which has led to additional stress and marring of my character. Copies of the police reports will be produced that illustrate the petty and destructive nature of the defendants. Ms. Keisha Christian, Mr. Venner's girlfriend, contacted the police about me and lied that I had been to her workplace harassing her. The facts will show that I went to her workplace at the invitation of her employer to speak with them. Further, she refused to speak to the police when they called her back about her own complaint but instead tried to pass the phone call onto a male 3rd party -- further destroying my name/character in the community.
14. Several mitigating steps have been taken to stop the irreparable reputational damage that has been caused by these parties. The websites have been contacted but they do not remove content once posted. The effect being that this content will be up for infinitum and available on the web for viewing by anyone. The police have been contacted but they seem ill prepared to do anything about the situation either.
15. Ms. Keisha Christian also made a habit of fabricating stories about me to Mr. Venner when I first met him. I have text message evidence to support this and can demonstrate where she even went as far as calling me a "fat black gorilla". The text message and email evidence is over 50 pages and will be submitted to the court as evidence during trial.

16. I have only attached samples of some comments in this statement of claim but there are many more. The defendants have ruined my reputation both in these islands and abroad to satisfy a personal vendetta.

AND THE PLAINTIFF claims:

1. The sum of CI \$100,000
2. Costs of \$300.00
3. Retraction/Apology letter to be posted on Facebook or other media forum that will be widely disseminated.

If, within the time for returning the Acknowledgement of Service, the Defendant pays the total amount claimed of \$100,300.00 further proceedings will be stayed. The money must be paid to the Plaintiff.

As mentioned to you when we met at my office, we conducted an investigation on a website address of josevenner.com which had a photograph of Jose in a TSCL uniform. What is puzzling to us is that our investigations revealed that the GoDaddy domain was registered in your name on August 15th, 2011 with a Biscayne Bay, Aventura, Florida address, your email address and Cayman phone number. We were going to conduct additional investigations and were advised to report the matter to ICTA however the picture of Jose in our uniform has since been removed.

I will speak to Inspector Best and let him know that we will warn Jose accordingly.

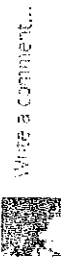

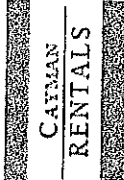

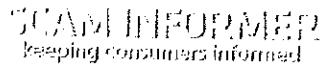
