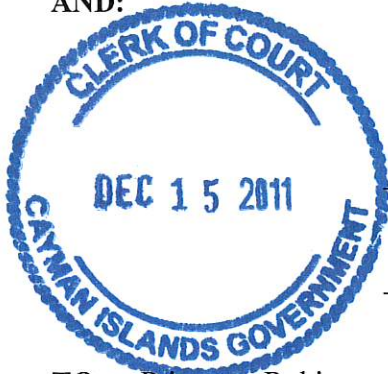

WRIT OF SUMMONS



TO: Princeton Robinson of PO Box 2868, Grand Cayman KY1-1112

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495, George Town, Grand Cayman KY1-1106, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

NOTE – This Writ may not be served later than 4 calendar months beginning with the date of issue unless renewed by order of the Court.

STATEMENT OF CLAIM


1. The Plaintiff is a Bank carrying on business at 25 Main Street, PO Box 68, George Town, Grand Cayman KY1-1102 and elsewhere and the Defendant has, and at all material times has been, a customer of the Plaintiff.
2. The Defendant is currently indebted to the Plaintiff in respect of his Loan Account #103-84676 in the principal sum of CI\$21,447.22 and is also liable in respect of interest on the principal sum in the amount of CI\$77.33 and continuing from the date hereof at the rate of CI\$4.07 per diem until payment.
3. Pursuant to clauses 2 and 3 of the Bill of Sale agreement dated 2nd April 2009 the Plaintiff shall have the right to demand payment of the principal sum and interest due at any time and that if default be made in payment of any installment when it became due the balance of the said principal sum then remaining unpaid together with interest accrued would at once become payable. The rate of interest is 8.50% per annum. Interest is payable from 23rd November 2011.
4. In or about December 2009 there was default in payments due to the Plaintiff and since that date payments to the account have not been made in the required sum. The security for the loan was sold in or about February 2010 in part satisfaction of the debt and the balance claimed represents the remaining shortfall.
5. Despite a written demand made to the Defendant by the Plaintiff's attorneys demanding payment of the outstanding amount no payments have been made.
6. The Defendant is therefore indebted to the Plaintiff in respect of the debt in the principal sum of CI\$21,447.22 together with interest of CI\$77.33 and continuing from the date hereof at the rate of 8.50% per annum, being a daily sum of CI\$4.07.

AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANT:

1. Payment of the principle sum of CIS\$21,447.22.
2. Interest of CI\$77.33 and continuing from the date hereof at the rate of 8.50% per annum, being a daily sum of CI\$4.07.
3. Fixed costs of CI\$500.00 together with the prescribed court fees of CI\$314.47, alternatively costs to be assessed.
4. Further or other relief.

If, within the time limited for acknowledging service of these proceedings, the Defendant pays to the Plaintiff's attorneys the total amount claimed (including costs) further proceedings will be stayed.

In the case of a limited company, "residence" means its registered or principal office.

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS

1. The accompanying form of Acknowledgment of Service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495, Grand Cayman KY1-1106.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings must also serve a defence on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is endorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A Stay of Execution against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, issue a Summons for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian ad litem.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
