

GENERAL INDORSEMENT

THE PLAINTIFF claims:

- (1) A declaration that the First Defendant holds the 430.073 preference shares in the Second Defendant registered in its name ("the Shares") on trust for, or as nominee for, the Plaintiff in respect of the ownership of the Shares;
- (2) An order that the said trust over the Shares be executed;
- (3) An order that the First Defendant do transfer the Shares to the Plaintiff by executing an instrument of transfer of the Shares in favour of the Plaintiff;
- (4) An order directing the Second Defendant to register the Plaintiff on its share register as a member of the Second Defendant in respect of the Shares in place of the First Defendant;
- (5) An order directing the Third Defendant to provide its written approval for the transfer of the Shares, pursuant to Article 16 of the Second Defendant's Articles of Association;
- (6) Costs; and
- (7) Such further or other relief as the Court considers appropriate.
