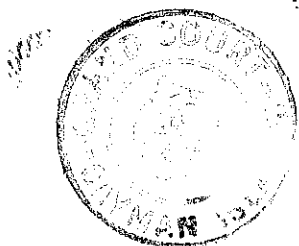

A. And I the said Venesha McLean for myself do say that:-




B. And I the said Heidi de Vries for myself do say:-
