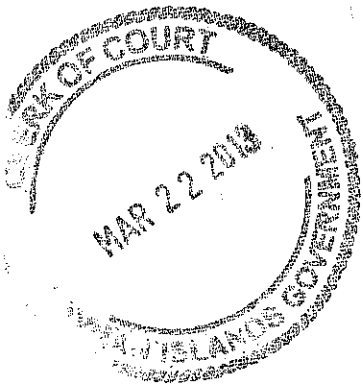

AMENDED ORIGINATING SUMMONS



TO: Trustcorp Limited (in liquidation) of 11-15 Seaton Place, St Helier, Jersey JE4 8XP, Channel Islands ("the Defendant").

LET THE DEFENDANT, within 428 days after service of this Summons on it, counting the day of service, return the accompanying Acknowledgment of Service to the Courts Office, P.O. Box 495G, George Town, Grand Cayman.

By this Summons, which is issued on the application of Kabushiki Kaisha Sigma Kabushiki Kaisha of 8-2-2-8 Minami Aoyama, Minato-ku, Tokyo, Japan, (the "Plaintiff" or "Sigma"), whose address for service is Walkers, Walker House, 87 Mary Street, 190 Elgin Avenue, George Town, Grand Cayman KY1-9001, the Plaintiff seeks the orders and declarations as set out at paragraphs 1-4, below.

1. A declaration that by reason of two instruments written in Japanese and (impliedly) governed by Japanese law executed on 14 March 2003 by Kenshin Oshima ("Mr Oshima") (one in respect of the Diamond Trust and one in respect of the Attila Unit Trust), and in the events that have occurred the Plaintiff is beneficially entitled to and entitled to be registered as the holder of all the units in the Diamond Trust and the Attila Unit Trust currently registered in the name of Mr Oshima;

2. An order that the Defendant as trustee of each of the Diamond Trust and Attila Unit Trust do alter the Register of Unit Holders in respect of each such Trust by substituting the name of the Plaintiff for the name of Mr Oshima as the holder of all the units currently registered in the name of Mr Oshima;
3. Further or other relief as the Court thinks fit; and
4. Costs.

If the Defendant does not acknowledge service, such judgment may be given or order made against or in relation to it as the Court may think just and expedient.
