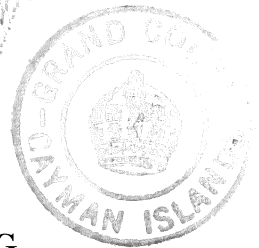
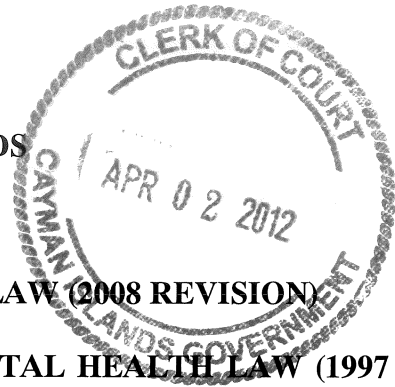

ORIGINATING SUMMONS

To: To SYLVIE REGINA HENNING AKA SYLVIE R. HENNING, of House No. 45, West Church Street, West Bay, Grand Cayman, PO Box 266, West Bay, Grand Cayman KY1-1301, Cayman Islands, British West Indies

LET THE RESPONDENT attend before a Judge of the Grand Court in Chambers at the Law Courts, George Town, Grand Cayman on the day of 2012 at o'clock in the fore/afternoon on the hearing of an application by the Applicants who seek the determination of the Court on the following question, namely an Order:-

1. That the Applicant be appointed guardian for the said SYLVIE REGINA HENNING AKA SYLVIE R. HENNING, (“the Patient”) and over her estate and effects with the following powers conferred upon him:-



- a) to control and manage the properties of the Patient.
 - b) to sell, acquire, charge or otherwise dispose of or deal with any of the Properties of the Patient.
 - c) to invest the proceeds of sale or any other monies belonging to the Patient in such securities as the Applicant for the time being is authorized by law to invest in trust funds.
 - d) to deposit into and withdraw from any account at any bank or lending institution in the Cayman Islands and elsewhere such of the Patient's monies as may be necessary for the proper maintenance upkeep and medical expenses and care of the Patient.
2. That the Applicant be appointed Receivers in relation to the administration of the estate of the Patient.
 3. That the Applicant shall keep proper records, books and accounts of the administration and management of the property of the Patient and whenever required by the Court to do so shall file in Court copies of such records, books and accounts.
 4. That the cost of this application and the cost of the guardian and receiver incidental to and consequent upon the Order shall be paid from the estate and property of the Patient.

Notice for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words “sued as (*the name stated on the Originating Summons*)”.
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description “Partner in the firm of (.....)” after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description “trading as (.....)” after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorized to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
