AMENDED ORDER

UPON HEARING Counsel for the Joint Official Liquidators (the "JOLs") of Sextant Strategic Global Water Fund Offshore Ltd. (In Liquidation) (the "Water Fund") on their Summons dated 5th April 2011.

AND UPON hearing Counsel for Barfield Nominees Limited, Account Nos. TOT 7 and TOT 10 ("Barfield")

AND UPON hearing Counsel for the Trustees of the Squirrel Trust and Republic Nominees Ltd


AND UPON reading the Seventh Affidavit of Kenneth Krys sworn on 4th April 2012.

IT IS HEREBY ORDERED that:-

1. The JOLs' attorneys shall prepare and deliver to the Judge's secretary a composite Liquidation File relating to this proceeding and FSD Cause 137 of 2010 (AJJ) containing copies of the petition, summonses, orders, notices, affidavits and reports arranged in chronological order, together with an index.

2. The fees and expenses of the JOLs for the period 1st August 2011 to 31st January 2012 in the sum of US\$294,460.52, made up of the JOLs' fees of US\$170,884.00 and expenses of US\$530.09 and the legal fees and expenses of the JOLs' attorneys being US\$123,046.43, is hereby approved and the payment of such remuneration out of the assets of the Water Fund as an expense of the liquidation be hereby approved.
3. The JOLs' costs of this application shall be paid out of the assets of the Water Fund as an expense of the liquidation.
4. Barfield's costs of the application, assessed in the sum of US\$1,000, shall be paid out of the assets of the Water Fund as an expense of the liquidation.
5. 4-The JOLs shall apply for approval of their remuneration and expenses for the period from 1st February to 31st July 2012, such application to be heard on 9th October 2012.
