ORDER

AND UPON Counsel for the Defendant undertaking to file a further affidavit exhibiting the Search Reports in respect of Echemus Group L.P., Echemus Investment Management Ltd., Echemus International, Ltd., all dated 18 January 2012;

AND UPON hearing Counsel for the Defendant;

IT IS HEREBY ORDERED THAT:

 - 1.3 On Martin S. Kenney by way of personal service at the offices of Martin Kenney & Co, Third Floor, Flemming House, Road Town, Tortola, BVI, or elsewhere in the BVI;
 - 1.4 On CC International Limited at its registered office at Dixcart Management Nevis Limited, P.O. Box 598, Dixcart House, Fort Charles, Charlestown, Nevis, Saint Kitts and Nevis; and
 - 1.5 On James Little, by way of personal service at 316 Wyndhurst Avenue, Baltimore, Maryland, 21210, U.S.A., or elsewhere in the U.S.A.
- 2 No order on the application for leave to serve the Costs Summons out of the jurisdiction on Echemus International, Ltd., but liberty to re-apply.
- 3 Not earlier than 31 days after service of the Costs Summons on some or all of the Costs Parties, the Costs Summons be listed for further directions.
- 4 Costs reserved.
