ORDER

UPON the application of the Joint Official Liquidators (the **JOLs**) of Cedar Lane Entertainment, Ltd (the **Feeder Fund**) by Summons dated 30 April 2012

AND UPON reading the Second Affidavit of Michael Pearson sworn on 7 May 2012 and the Third Affidavit of Michael Pearson sworn on 11 May 2012

AND UPON hearing counsel for the JOLs


**IT IS ORDERED AND DIRECTED THAT:**

1. the JOLs are sanctioned to exercise their power to sell property of the Feeder Fund by causing the Feeder Fund to enter into:
  - (a) the Deed of Assignment between the Feeder Fund, Cedar Lane Entertainment Fund, Ltd (in official liquidation) (the **Master Fund**) and Brookhollow V, Ltd (**Brookhollow**) dated 22 March 2012 (the **Deed of Assignment**); and

- (b) the Deed of Indemnity and Contribution between the Master Fund, the Feeder Fund and Brookhollow dated 22 March 2012;
2. as soon as is reasonably practicable after 31 December 2012, the JOLs shall (a) file a report to the Court in relation to the liquidation and in particular the progress of the claims assigned to Brookhollow pursuant to the Deed of Assignment, and (b) file an application for approval of their remuneration incurred between the date of their appointment and 31 December 2012;
  3. thereafter, the JOLs shall file reports to the Court and seek approval of their remuneration on a six monthly basis, with the next such report and application to cover the period from 1 January 2013 to 30 June 2013;
  4. all reports and applications for approval of remuneration shall be made on a consolidated basis in relation to the Feeder Fund in these proceedings and the Master Fund in FSD No. 109 of 2010 – AJF; and
  5. the JOLs' costs of this application be paid from the liquidation estate as an expense of the liquidation.
