ORDER

UPON the Amended Petition presented herein on 13 February 2012 (the "**Petitioner**") by Trident Microsystems (Far East) Ltd. (the "**Petitioner**")

AND UPON reading the First Affidavit of Andrew Hinkelman and exhibits thereto, the First, Second, Third, Fourth, Fifth, Sixth, Seventh, Eighth, Ninth and Tenth Affidavits of Eleanor Fisher, the First, Second, Third, Fourth and Fifth Affidavits of Gordon MacRae, the First, Second, Third, Fourth, Fifth and Sixth Affidavits of Richard Chesley, the First, Second, Third, Fourth and Fifth Affidavits of David Teichmann and the Second Affidavit of Rachel Baxendale, exhibits EF-3, EF-7, EF-9, EF-15, EF-16, EF-19, GM-3, RAC-6, RAC-8, DT-1, DT-2, DT-3, DT-4, DT-5, DT-7, DT-8, DT-9, DT-13, RAC-3, DT-22, RCB-8, RCB-9 and selected extracts from exhibits EF-8, EF-14, EF-17, EF-18, GM-4, GM-5 and RCB-3, provided that all previous Orders as to the sealing of affidavits and exhibits do stand

AND UPON hearing Counsel for the Petitioner and Counsel for UMC Group USA

IT IS ORDERED THAT:

- 1 The hearing of the Petition be adjourned until 10 a.m. on 8 August 2012.

- 2 Within 14 days of the filing date of this Order the Joint Provisional Liquidators of the Petitioner ("JPLs") shall advertise the date for the adjourned hearing of the Petition once in the *Cayman Islands Gazette* and once in the *Wall Street Journal (International Edition)*.
- 3 The JPLs shall send a copy of this Order to all known creditors of the Company by post, courier or email, within 14 days of the filing date of this Order, together with a report substantially in the same form as their report to the Court of 24 May 2012, with any necessary redactions.
- 4 The JPLs and the Petitioner each be at liberty to apply to restore the Petition for hearing at a date earlier than 10 a.m. on 8 August 2012 whereupon the JPLs and/or the Petitioner, as necessary, shall advertise the new date for the adjourned hearing of the Petition once in the *Cayman Islands Gazette* and once in the *Wall Street Journal (International Edition)*, such advertisements to be published not later than 14 days prior to such hearing. The JPLs shall send notice of the new date for any such adjourned hearing of the Petition to all known creditors of the Company by post, courier or email, not later than 14 days prior to such hearing.
- 5 Creditors of the Petitioner be at liberty to apply to the JPLs to request that the Petition be heard at a date earlier than 10 a.m. on 8 August 2012, whereupon the JPLs shall take such steps as may be necessary to bring the matter to the Court's attention.
- 6 A copy of the Court's ruling granting the adjournment should be provided as soon as practicable to the Delaware Bankruptcy Court.
- 7 The JPLs shall use their best endeavours to elicit replacements for ARM Limited and Wipro Technologies on the Creditors' Committee.



8 The JPLs' costs of this application be an expense in the provisional liquidation.
