2. The Defendants do pay the Plaintiff's Cayman legal costs (including Appleby's costs of communicating with and taking instructions from Skadden Arps, Slate, Meagher & Flom in Hong Kong) subsequent to 27 March 2012 and until 4 June 2012 or such other date as the Defendants provide to the Plaintiff original counterparts of the executed releases, to be taxed on the indemnity basis if not agreed.
