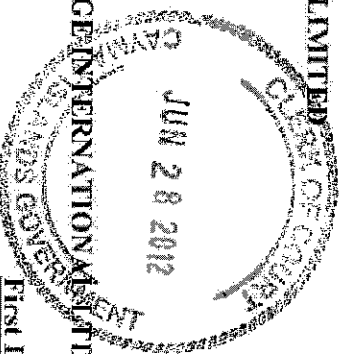
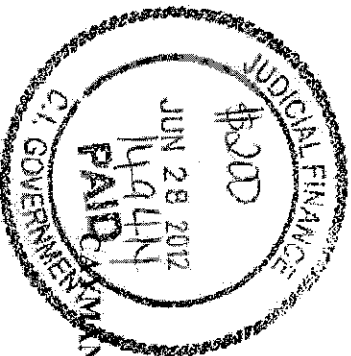

ORIGINATING SUMMONS

LET THE DEFENDANTS, Cayman Food and Beverage International Ltd. and First Regents Bank & Trust (Cayman) Ltd., attend before the Judge of the Grand Court in Chambers, at the Law Courts, George Town, Grand Cayman on the day of 2012 at o'clock in the fore/afternoon on the hearing of an application on behalf of the PLAINTIFF, Esso Cayman Limited, for the following Order:

1. The Plaintiff hereby applies to the Court for an order that Cayman Food and Beverage International Ltd. ("Cayman Food and Beverage") or, in the alternative, First Regents Bank & Trust (Cayman) Ltd. ("First Regents") be compelled to make the Register of Members of Cayman Food and Beverage available for inspection and copying pursuant to Section 44 of the Companies Law (2011 Revision) ("Law").
2. The parties to be served are:

(b) First Regents Bank & Trust (Cayman) Ltd., Governors Square, Second Floor, 23 Lime Tree Bay, George Town, Grand Cayman, Cayman Islands.

3. The Plaintiff will be relying on the facts set out in the Affidavit in Support of Summons of Edward A. Caudelron dated 27th June 2012 in support of this application.
4. The Plaintiff seeks an order that Cayman Food and Beverage or, in the alternative, First Regents, be compelled to make the Register of Members of Cayman Food and Beverage available for inspection and copying pursuant to Section 44 of the Law.
5. The Plaintiff wishes to inspect and copy the Register of Members of Cayman Food and Beverage and cannot do so in the absence of the order sought.
6. To the best of the Plaintiff's knowledge and belief the facts stated in this Summons are true.
