ORDER FOR DIRECTIONS

UPON this matter having been transferred to the Financial Services Division, and the parties' request for a Case Management Conference accordingly;

AND UPON hearing counsel for the Plaintiff and counsel for the Defendant;

IT IS HEREBY ORDERED THAT:

1. The Plaintiff shall serve, by 3 August 2012, a Re-Amended Statement of Claim, such pleading to include a full response to the Defendant's Request for Further and Better Particulars of the Statement of Claim dated 11 May 2012.
2. The Defendant is to serve, by 31 August 2012, a Defence to the Re-Amended Statement of Claim and, if so advised, any Counterclaim.
3. The Plaintiff is to serve, by 14 September 2012, any Reply and Defence to any Counterclaim.
4. With respect to the Defendant's draft Security for Costs Application (the "Security for Costs Application"):


- 4.1 In the absence of a Consent Order resolving the Security for Costs Application the Defendant shall file and serve his evidence in support thereof by 20 July 2012;
 - 4.2 The Plaintiff shall file and serve any evidence in opposition to the Defendant's evidence by 27 July 2012;
 - 4.3 The Defendant shall file and serve any evidence in reply by 2 August 2012; and
 - 4.4 The Security for Costs Application shall be listed for hearing before Mr Justice Cresswell on a date to be fixed and with a time estimate of half a day.
5. The Defendant's Summons dated 16 May 2012 under GCR Order 18, rule 19 (the "Strike Out Application") be adjourned, with liberty to apply.
 6. The Plaintiff's Summons dated 1 May 2012 under GCR Order 14, rule 1 (the "Summary Judgment Application") be adjourned, with liberty to apply.
 7. The costs of the Plaintiff's Re-Amended Statement of Claim, in any event, shall be borne by the Plaintiff, unless the Plaintiff makes application for a different Order as to the costs of that amendment.
 8. The costs of the Summary Judgment Application be reserved.
 9. The costs of the Security for Costs Application be reserved.
 10. The costs of the Strike Out Application be reserved.



11. The costs for the hearing of this Case Management Conference be costs in the cause.
