**ORDER FOR DISSOLUTION  
AND APPROVAL OF  
LIQUIDATORS' FEES**

**UPON HEARING** counsel for the Official Liquidator upon his Summons for an order that Zephyr International Ltd. (In Liquidation) (the "**Company**") be dissolved and the Official Liquidator's fees be approved.

**AND UPON** reading the Official Liquidator's final report and accounts and supplementary report and accounts.

**AND UPON** reading the Affidavit of Richard Fogerty dated 31 May 2012.

**IT IS ORDERED** that:

1. Mr Richard Fogerty of Zolfo Cooper Cayman Islands be released from the performance of any further duties as Official Liquidator of the Company.
2. The Company be dissolved from the date of the making of this Order.
3. Further to the Order of the Chief Justice dated 31 July 2003 permitting the pooling of the assets of the Company with the assets of Queens Cross Group Ltd. (In Liquidation), Overseas Foreign Holdings Ltd. (In Liquidation) and Ingleton International Ltd. (In Liquidation) (together the "**Pooled Companies**"), the fees and disbursements of the Official Liquidator in respect of the Pooled Companies be approved in the sum of US\$376,858.45 for the period from 1 November 2001 to 31 May 2012.


4. There be no Order as to costs.

**AND IT IS FURTHER DIRECTED** that:

5. The Official Liquidator's liquidation file shall be preserved until 14 July 2015.
6. The Company's books and records that are in the possession of the Official Liquidator may be destroyed after 12 months from the date of this Order.
