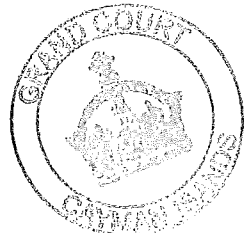

IT IS ORDERED as follows:

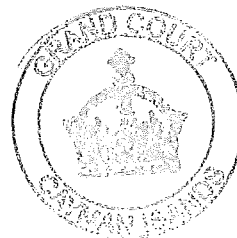
