**WRIT OF SUMMONS**

**THIS WRIT OF SUMMONS** has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within (14 Days) after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Courts Office, PO Box 495GT, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment of Service within the time stated, or if you return the Acknowledgement of Service without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and Judgment may be entered against you forthwith without further notice.

Issued this 6 day of August 2012

NOTE – This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by Order of the Court.

## STATEMENT OF CLAIM

---

---

1. The Plaintiff is a body corporate having perpetual succession established under the Cayman Islands Banking laws and expressly empowered by the said laws to grant loans in accordance with the said laws including retail lending.
2. The Defendant at all material times was a resident of the Cayman Islands, the Defendant being a customer of the Plaintiff who obtained financing from the Plaintiff for the purposes of financing a dump truck for his business.

### **The Agreement**

3. By an Offer Letter dated 11 August 2010, and loan agreement dated 18 August 2010, ("**Agreement**"), the Plaintiff agreed to advance to the Defendant the sum of CI\$17,000 for the purposes approved in the Agreement, i.e. the purchase of a 1989 International model Dump Truck.

### **Terms of the Agreement**

4. The terms of the Agreement as set out in the Agreement *inter alia* was that the Defendant repay the Loan of CI\$17,000 by monthly instalments of CI\$466.00 (four hundred & Sixty Six dollars), over a period of 42 months commencing 30 November 2010, at an effective rate of interest of 8% per annum.

By paragraph 6 of the Loan Agreement the Defendant agreed to pay the Plaintiff all administrative costs and legal fees in the event of enforcement of the loan.

5. The Defendant is in default of the above described loan as detailed in the particulars of default set out below in paragraph 10.

### **Demand Letters**

6. A letter from the Plaintiff's attorneys to the Defendant dated 14 May 2012 which was served on the Defendant on 15 May 2012 advised the Defendant to make arrangements with the Plaintiff to bring the arrears of CI\$5,377.46 up to date within 14 days of receipt of the letter or legal proceedings would commence against the Defendant.
7. There was no reply to the Plaintiffs letter of 14 May 2012
8. Another formal Demand letter from the Plaintiffs attorneys dated 13 June 2012 was served on the Defendant on 15 June 2012, filed 8 August 2012, requesting payment of the outstanding loan and interest due to the Plaintiff within 7 days of

the date of service of the demand letter or to make reasonable arrangements with the Plaintiff to satisfy the indebtedness, or face legal consequences.

9. Again the Defendant has not replied to the said Demand Letter of 13 June 2012 and to date the Defendant has not honoured his obligations to the Plaintiff under the Agreement.

### **PARTICULARS**

10. The Defendant has failed to pay the monthly installments due under the Agreement. The current state of the account between the Plaintiff and the Defendant as of **7 May 2012**, the date of last assessment by the Plaintiff, is as follows;

- (a) The total amount of principle outstanding is CI\$15,885.51
- (b) The total amount of interest outstanding is CI\$90.52..
- (c) The current arrears of monthly payments agreed on is CI\$5,377.46
- (d) The amount of interest accruing on a daily basis is CI\$3.48
- (e) The current period in default of payment is 343 days.
- (f) The current rate of interest under the agreement is 8 %

The Defendant therefore is in breach of the Agreement with the Plaintiff.

11. The Plaintiff claims pre-judgment interest in accordance with the terms of the Agreement as described in paragraphs 10 (b) and (d) and (f), and post judgment interest in accordance with the Judicature Law (2007 Revision), and in accordance with the Judgment Debts Rate of Interest Rules (2010);

### **AND THE PLAINTIFF CLAIMS**

- (1) Immediate payment of all monies due to the Plaintiff by the Defendant under the Agreement the amount of which as of 7 May 2012, was CI\$15,976.03 principle & interest, and accruing on a daily basis;
- (2) Pre-judgment interest in accordance with the terms of the Agreement between the parties as described above in paragraph 11 and post judgment interest in accordance with the Judicature Law (2007 Revision), and Judgment Debts Rate of Interest Rules (2010);
- (3) Court fees including *ad valorem* fees;


- (4) Legal costs to conclusion of these proceedings;
- (5) Further or other relief as this Honourable Court deems fit.

Note: Further proceedings will be stayed if within the time limit for acknowledging service of this writ, the Defendant pays the amount of principle & interest claimed by the Plaintiff and all accrued interest, costs and legal fees to date, payment to be made to the Plaintiff or his attorney.

**DIRECTIONS FOR ACKNOWLEDGEMENT OF SERVICE OF  
WRIT OF SUMMONS**

1. The accompanying form of ***Acknowledgment of Service*** should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion, it must be delivered or sent by post to the Law Courts, PO Box 495, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the Proceedings ***must also serve a Defence*** on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for Judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter Judgment against him without further notice.

3. A ***Stay of Execution*** against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any Judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a Stay, Execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, ***issue a Summons*** for a Stay of Execution, supported by an Affidavit of his Means. The Affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

### Notes for Guidance:

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a Writ served on the Defendant personally is treated as having been served on the day it was delivered to him/her.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a **FIRM** and an Attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authorized to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on his behalf.
7. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.

**Defendant in person:** where the Defendant is acting in person, he/she must give his post office box number and the physical address of his/her residence or, if he/she does not reside in the Cayman Islands, he/she must give an address in Grand Cayman where communications for him/her should be sent. In the case of a Limited Company "residence" means its registered or principal office.
