ORDER

UPON hearing Counsel for the Trustee in Bankruptcy on the Summons dated the 24th of September 2012

AND UPON READING First Affidavit of Randall Martin sworn on 26th September 2012

IT IS HEREBY ORDERED that:

1. The fees and disbursements of Mr. Michael Saville, the Trustee's Agent, for the period from 13th January to 1st September 2011 in the total sum of US\$60,917.39 are hereby approved and shall be paid out of the moneys in court as follows -
 - (a) Estate of Joseph Otu (#240/2010) – US\$33,365.83
 - (b) Estate of Josephene Otu (#242/2010) - US\$27,551.56

2. The Petitioners' costs of the petitions, assessed in the sum of US\$7,115.46, shall be paid out of the moneys in court as follows –
 - (a) Estate of Joseph Otu (#240/2010) – US\$3,557.73
 - (b) Estate of Josephene Otu (#242/2010) - US\$3,557.73

3. Except as provided in paragraph 4 below, the fees of Bodden & Bodden in their capacity as attorneys for the Trustee in Bankruptcy and the Trustee's Agent shall be taxed on the indemnity basis, such taxation to be conducted by the Judge.

4. The fees of Bodden & Bodden in the sum of CI\$8,100.00 (reflected in the Invoice dated 31st July 2012) are hereby approved and shall be deducted from the proceeds of the sale of the Alhambra Apartment pursuant to paragraph 4(a) of the Order made on 18th May 2012.
5. No order for the costs of the Summons.
