**ORDER**

**UPON READING** the Summons dated 26 September 2012 issued by the Joint Official Liquidators (the **JOLs**) of HSH Cayman I GP Ltd (in liquidation) (**Cayman GP I**), HSH Cayman II GP Ltd (in liquidation) (**Cayman GP II**), HSH Cayman V GP Ltd (in liquidation) (**Cayman GP V**) and HSH Coinvest (Cayman) GP Ltd (in liquidation) (**Cayman GP Coinvest**) (collectively, the **Cayman GPs**)

**AND UPON** reading the Twelfth Affidavit of Ian Stokoe sworn on 3 October 2012


**IT IS ORDERED AND DIRECTED THAT:**

1. the **JOLs'** remuneration of US\$24,916.13 incurred as liquidators of Cayman GP I during the period from 1 March 2012 to 31 August 2012 be approved and paid from the assets of Cayman GP I;

2. the JOLs' remuneration of US\$11,622.27 incurred as liquidators of Cayman GP II during the period from 1 March 2012 to 31 August 2012 be approved and paid from the assets of Cayman GP II;
3. the JOLs' remuneration of US\$2,828.66 incurred as liquidators of Cayman GP V during the period from 1 March 2012 to 31 August 2012 be approved and paid from the assets of Cayman GP V;
4. the JOLs' remuneration of US\$13,320.99 incurred as liquidators of Cayman GP Coinvest during the period from 1 March 2012 to 31 August 2012 be approved and paid from the assets of Cayman GP Coinvest;
5. the JOLs' shall apply to the Court for approval of their remuneration and expenses for the period from 1 September 2012 to 28 February 2013, such application to be heard on Friday 5 April 2013;
6. the costs of this application be paid out of the assets of each of the Cayman GPs pro rata to the amounts of the JOLs' remuneration as expenses of the respective liquidations.
