**ORDER**

**UPON** the applications by Geoffrey Varga as official liquidator (the "OL") of Security Capital Limited (the "Company") by summons dated 23 October 2012 seeking approval of his remuneration for the period from 1 April 2012 to 30 September 2012 and by summons dated 23 October 2012 seeking the appointment of Mark Longbottom as a joint official liquidator of the Company (collectively, the "Summonses")

**AND UPON** reading the Ninth Affidavit and Exhibits of Geoffrey Varga sworn on 28 November 2012 and the First Affidavit of Mark Longbottom sworn on 28 November 2012

**AND UPON** hearing counsel for the OL

**IT IS ORDERED THAT**

1. the remuneration incurred by the OL between 1 April 2012 and 30 September 2012 be approved in the amount of US\$85,622 and paid from the liquidation estate;
2. Mark Longbottom of Kinetic Partners (Cayman) Limited, The Harbour Centre, 42 North Church Street, P.O. Box 10387, Grand Cayman, Cayman Islands, KY1 1004 (telephone: +1 345 623 9900; email: [Mark.Longbottom@kinetic-partners.com](mailto:Mark.Longbottom@kinetic-partners.com)) be appointed as a joint official liquidator of the Company;

3. Mr Longbottom be sanctioned to exercise all of the powers, jointly and severally, that Mr Varga has been sanctioned to exercise pursuant to the supervision order dated 28 May 2009; and
4. the costs of the Summonses be paid from the liquidation estate as an expense of the liquidation.
