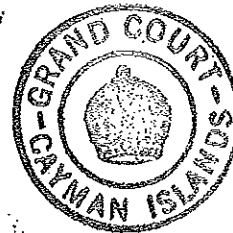


IT IS ORDERED that:

1. The Plaintiff shall serve his skeleton argument for trial on the Defendants on or before Thursday 23 January 2014.
2. The Defendants shall serve their skeleton arguments for trial on the Plaintiff on or before Thursday 30 January 2014.

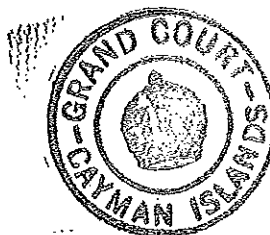
3. All parties shall deliver their skeleton arguments to the assigned judge's assistant by 9.00 a.m. Friday 31 January 2014.
4. The trial bundles, agreed chronology, dramatis personae, list of issues, list of agreed facts and a plan shall be delivered to the assigned judge's assistant by 9.00 a.m. Friday 31 January 2014. The parties shall use their best endeavours to lodge an agreed authorities bundle at the same time.
5. Monday 3 February and Tuesday 4 February 2014 shall be set aside as reading days and the trial shall commence on Wednesday 5 February 2014.
6. The parties shall arrange for the trial to be transcribed.
7. The order of proceedings at trial shall be as follows: Plaintiff's opening submissions; Plaintiff's evidence; First Defendant's opening submissions; Second-Fourth Defendants' opening submissions; Fifth-Sixth Defendants' opening submissions; First-Fourth Defendants' evidence; Fifth-Sixth Defendants' evidence; First Defendant's closing submissions; Second-Fourth Defendants' closing submissions; Fifth-Sixth Defendants' closing submissions; Plaintiff's closing submissions.
8. Costs in the cause.




