**AND UPON** hearing Counsel for the Respondents and Counsel for the Appellant


**IT IS ORDERED AND DIRECTED BY CONSENT THAT:**

1. The Appellant do, within seven days of the date hereof, procure some sufficient person on its behalf (other than a subsidiary of the Company and to the satisfaction of the Court in case the parties differ) to give security in the sum of US\$106,226.30 conditioned to answer costs in case any shall be ordered to be paid by the Appellant to the Respondents on the appeal.

2. The source of funding of such security is to be disclosed by the Appellant by letter to the Respondents' attorneys and the Respondents shall have liberty to apply to the Court in this regard.
3. In default of the Appellant so procuring such security by the time aforesaid the Respondents shall have liberty to apply to the Court for an order in the terms of paragraphs 3, 4 and 5 of their Summons.
4. Costs in the appeal.
