ORDER

UPON the Amended Petition of Ronan Guilfoyle and Graham Hampson ("the Directors"), the directors of JP SPC 1 ("the SPC") dated 13 December 2012 and amended by order of 25 January 2013 for a receivership order in respect of Axiom Legal Financing Fund, a segregated portfolio of the SPC ("the Portfolio")

AND UPON HEARING Leading Counsel for the Directors, Counsel for Terry Harvey, an investor in the Portfolio, Counsel for Tangerine Investment Management Limited, an investor in the Portfolio, Counsel for 3 other investors and Counsel for the Cayman Islands Monetary Authority ("CIMA")

AND UPON READING the Affidavits listed in the Schedule attached to this Order

IT IS HEREBY ORDERED AND DIRECTED that:

1. The business and segregated portfolio assets of the Portfolio shall be managed by Michael Edward George Saville and Hugh Dickson of Grant Thornton Specialist Services (Cayman) Limited and James Earp of Grant Thornton UK LLP ("the Receivers") for the purposes specified in section 224(3) of the Companies Law ("the Law");
2. Each of the Receivers be authorized to exercise the powers conferred by the Companies Law either alone or together with either or both of the others;
3. The Receivers shall report to the Court and to CIMA by 15 May 2013, and shall apply for the listing of a further hearing herein on 23 May 2013;
4. The Receivers' fees and expenses shall be payable out of the assets of the Portfolio pursuant to section 228 of the Law in priority to all other claims, and the Receivers shall

apply for such fees and expenses which have been incurred up to 15 May 2013 to be approved by the Court at the said hearing listed for 23 May 2013;

5. The Receivers and CIMA are to be at liberty to apply for further directions and generally;
6. The First Affidavit of Ronan Guilfoyle and exhibit RG1 thereto shall be sealed and not made available to anyone other than the Directors, CIMA and the Receivers without leave of the Court;
7. The costs of the Directors of the Petition shall be paid out of the assets of the Portfolio;
8. Tangerine Investment Management Limited shall pay to the Portfolio 60% of the costs of the Directors of the Petition and shall pay to Terry Harvey 60% of his costs of the Petition, such costs to be taxed on the standard basis if not agreed;
9. The balance of Terry Harvey's costs shall be paid from the Portfolio on the standard basis, to the extent that they are not met by Tangerine Investment Management Limited.
