

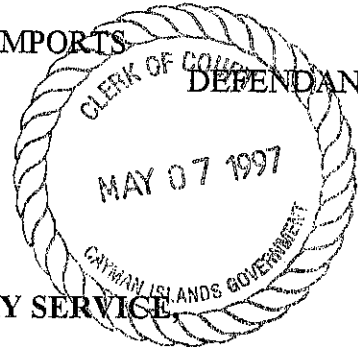

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff of Blenheim Road, Cressex Business Park, High Wycombe, Buckinghamshire HP12 3RS, United Kingdom, in respect of the claim set out in the Statement of Claim annexed.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this *7th* day of *May* 1997.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

1. The Plaintiff's claim is for £8,345.46, the price of work done and air freight services rendered to the Defendant at her request.

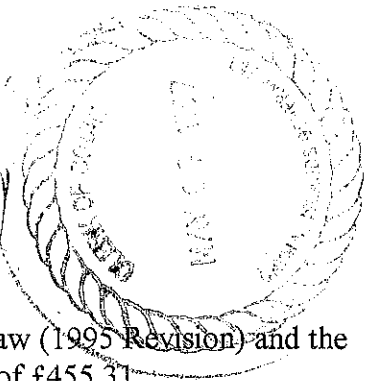
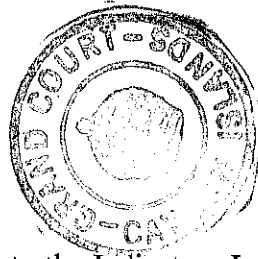

The Plaintiff is entitled to and hereby claims pre-judgment interest on the sum aforesaid pursuant to the Judicature Law (1995 Revision) and the Judgment Debts (Rates of Interest) Rules 1996 at the rate of 9% per annum from the said dates, amounting to £455.31 at the date hereof and hereafter continuing until judgment or sooner payment at the rate of £2.06 per day.

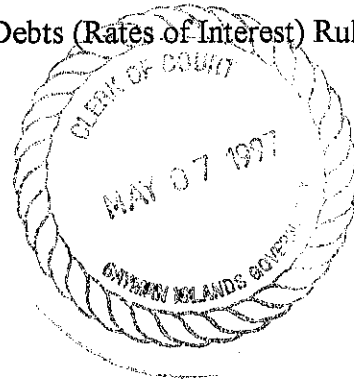
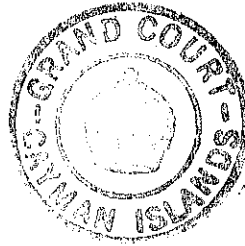
AND THE PLAINTIFF CLAIMS:

- (1) the principal sum of £8,345.46
- (2) pre-judgment interest thereon pursuant to the Judicature Law (1995 Revision) and the Judgment Debts (Rates of Interest) Rules 1996 in the sum of £455.31.



- (3) further pre-judgment interest thereon from the date hereof until judgment or sooner payment pursuant to the Judicature Law (1995 Revision) and the Judgment Debts (Rates of Interest) Rules 1996
- (4) Post-judgment interest thereon pursuant to the Judgment Debts (Rates of Interest) Rules 1996 from the date of judgment.
- (5) Costs.
