
EX PARTE ORIGINATING SUMMONS

LET ALL PARTIES CONCERNED attend before the Judge in Chambers at the Law Courts, George Town, Grand Cayman on the _____ day of _____ 1997 at _____ o'clock in the fore/afternoon, on the hearing of an application by the Honourable Attorney-General for orders that:

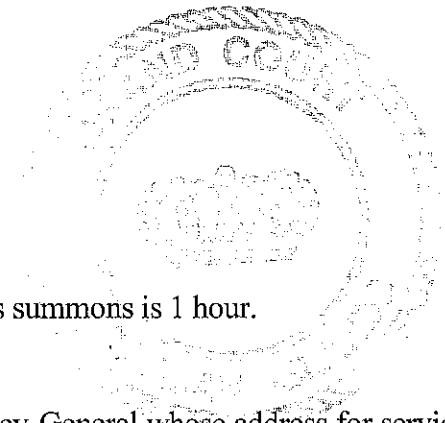
1. LONNIE RAYMOND LEWIS, WILLIAM BOYD KIPER, PATRICK A. RADZIKOWSKI (also known as PAT RADZ), JAMES R. HISER, JACK EDWIN ERNSBERGER (also known as JACK ELLIS) ANNAMARIE ELLEN KIPER, BRIAN HOPKINS (also known as BERNIE HARRIS), ANDREW JAMES CONE, PIONEER INDUSTRIES INC., PREMIUM PLACEMENTS INC., BARRISTER INVESTMENTS INC., HEALTHY SNACKS INC., UNITED LOCATORS OF AMERICA INC., CONSOLIDATED GROUP INC., WHOLESALE NETWORK INC., QUALITY PLACEMENTS INC., GLOBAL EXPRESS LTD., WORLD VENDING INC., FINAL CREDIT WHOLESALE INTERNATIONAL LTD. (also known as FUR CD WHOLESALE INTERNATIONAL), ROYAL ADVERTISING CONSULTANTS INC. (also known as FRESH START INDUSTRIES), UNITED CONTINENTAL INDUSTRIES INC., INDEPENDENT VENDORS ASSOCIATION INC. (formerly SUCCESS-LINE INDUSTRIES INC.), NATIONAL BUSINESS CONSULTANTS INC. and BANK OF BERMUDA (CAYMAN) LTD., hereinafter referred to as "the Defendants", be restrained whether by themselves or by their servants, directors, officers or agents or otherwise howsoever until further order from dealing or attempting to deal in any way howsoever with any funds currently deposited to any account in Grand Cayman at Bank of Bermuda (Cayman) Ltd held in the name(s) of or for the benefit of any of the Defendants, and without prejudice to the generality of the foregoing, from in any way howsoever:-

- (a) transferring, assigning, withdrawing, removing from the jurisdiction, disposing of or otherwise dealing with any funds deposited to account number 75018140 held at Bank of Bermuda (Cayman) Ltd in the name of Global Express Ltd;
 - (b) transferring, assigning, withdrawing, removing from the jurisdiction, disposing of or otherwise dealing with any funds deposited to account number 75002321 held at Bank of Bermuda (Cayman) Ltd in the name of World Vending Inc.;
 - (c) transferring, assigning, withdrawing, removing from the jurisdiction, disposing of or otherwise dealing with any funds deposited to account number 75001994 held at Bank of Bermuda (Cayman) Ltd in the name of Final Credit Wholesale International Ltd (also known as Fur CD Wholesale International).
2. Bank of Bermuda (Cayman) Ltd is prohibited from disclosing the existence of this Order or any information relating thereto to any person or corporation, including the holder(s) of any of the accounts referred to in paragraph 1 above or any servants, directors, officers or agents of the said account holder(s), until 14 May 1997.
 3. The Court file in relation to this matter be deemed a closed file to be kept in a safe place in the office of the Clerk of Courts until further order.
 4. Substituted service of the Order of the Court and a copy of the affidavit of Stephen James Bonnar sworn in support thereof shall be effected upon the Defendants by:
 - (a) Effecting service of the said documents upon the Bank of Bermuda (Cayman) Ltd,
 - (b) Delivery of the said documents to the Office of International Affairs at the Department of Justice of the United States of America and to the Office of Statewide Prosecution, Fort Lauderdale, Florida, USA for onward delivery to the Defendants.
 5. Such further orders or directions as this Honourable Court shall deem fit.
