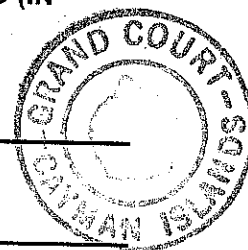

ORDER

UPON the adjourned application (the "**Application**") of Ian Stokoe (the "**Liquidator**"), in his capacity as the Official Liquidator of Tangerine Investment Management Limited (In Official Liquidation) (the "**Company**") by Summons dated 17 October 2014

AND UPON reading the Second Affidavit of the Liquidator filed on 16 October 2014 ("**Stokoe 2**"), the First Affidavit of Steven Jeremy Goodman (the "**Proposed Assignee**") filed on 17 October 2014, the Second Affidavit of the Proposed Assignee filed on 4 November 2014, the First Affidavit of Christopher Aurelio Levers filed on 8 December 2014, the First Affidavit of Hugh Dickson filed on 12 December 2014, the Third Affidavit of the Liquidator filed on 9 January 2015, the Third Affidavit of the Proposed Assignee filed on 12 January 2015, the Second Affidavit of Christopher Aurelio Levers filed on 21 January 2015, the First Affidavit of Ms Dawn Cummings ("**Ms Cummings**") filed on 23 February 2015, the Fourth Affidavit of the Proposed Assignee filed on 14 May 2015, the Fourth Affidavit of the Liquidator filed on 15 May 2015, together with the exhibits to each of the above affidavits (including the deed of assignment entered into between (i) the Company, (ii) the Liquidator and (iii) the Proposed Assignee on 18 March 2014 (the "**Deed of Assignment**"), exhibited to the said Second Affidavit of the Liquidator;

AND UPON reading the correspondence between Mourant Ozannes and Walkers dated 18 and 19 May 2015


AND UPON hearing Counsel for the Liquidator, Leading Counsel for the Proposed Assignee, Counsel for the Joint Receivers of the Axiom Legal Financing Fund Master SP and Counsel for Ms Cummings

IT IS ORDERED THAT:

1. The Liquidator be authorised:
 - (a) to enter into the Deed of Assignment; and
 - (b) in accordance with section 110(2)(a) and Part I of Schedule 3 to the Companies Law (2013 Revision), to assign various causes of action potentially vesting in the Company against each of (i) Mr Timothy Schools, (ii) Ms Cummings; and (iii) DMS Offshore Investment Services Limited to the Proposed Assignee upon the terms set out in the Deed of Assignment and otherwise to take all steps necessary to carry the Deed of Assignment into effect.
2. Liberty to apply.
3. Subject to the terms of the Deed of Assignment, the Liquidator's costs of and incidental to the Application be paid out of the assets of the Company.

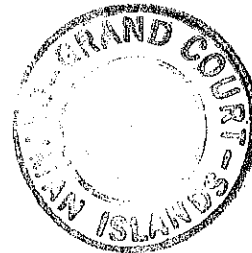

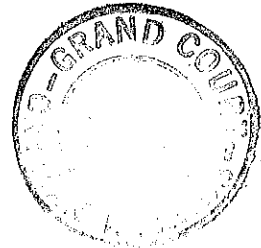
