PETITION



To the Grand Court of the Cayman Islands



THE HUMBLE PETITION of Royal Bank Of Canada International Currencies Fund Ltd (in Voluntary Liquidation) 62 Forum Lane, Camana Bay, P.O. Box 510, Grand Cayman, KY1-1106, Cayman Islands (the "Fund") shows that:

1. On 11 November 1982 the Fund was incorporated in the Cayman Islands as an exempt company. Its registration number is 13964 and its current registered office is c/o Ernst & Young Ltd, 62 Forum Lane, Camana Bay, P.O. Box 510, Grand Cayman, KY1-1106, Cayman Islands.
2. The Fund is an open-ended investment company. Its investment objective was to combine subscriptions to form substantial amounts in order that each class of its shares could participate in higher rates of interest normally offered for large sums of money and thus provide a net return over a spread of maturities higher than usually available to individuals investing smaller amounts. It was managed by Royal Bank of Canada Trust Company (Cayman) Limited.
3. On 25 January 2013 the Fund's sole voting shareholder passed a resolution to wind up the Fund and appoint Robin Lee McMahon and Keiran Hutchison as its Joint Voluntary Liquidators (together the "Liquidators").
4. The Liquidators seek guidance from the Court regarding the steps they may take to locate the Fund's remaining investors.


YOUR PETITIONER THEREFORE HUMBL Y PRAYS THAT
