AND UPON hearing Counsel for the Petitioner and Counsel for the Commonwealth of the Northern Mariana Islands


IT IS HEREBY ORDERED that the Debtor be and is hereby absolutely adjudged a bankrupt, and it is declared that the date of the act of bankruptcy is 10 May 2013.

AND IT IS FURTHER DIRECTED that:-

1. This Order shall be published in the *Gazette*.
2. The Debtor's public examination shall be adjourned to a date to be fixed.
3. The Trustee in Bankruptcy is hereby authorized and directed to appoint Kenneth Krys and Margot MacInnis of KRyS Global, Governor's Square, Building #6, 23 Lime Tree Bay, PO Box 31237, Grand Cayman, KY1-1104 ("the Trustee's Agents") as her agents (pursuant to section 13 of the Bankruptcy Law) in respect of the Debtor's property and for the purpose of administering her estate, with power to act jointly or severally, subject to obtaining the Court's prior approval to the terms of a written agency agreement.

4. The Trustee's Agent is authorized to pursue the ancillary petition filed in the United States Bankruptcy Court for the Southern District of New York (Case Nos. 13-11626) for recognition pursuant to Chapter 15 of the United States Bankruptcy Code.
5. The Debtor's costs of presenting the petition shall be paid out of the estate as an expense of its administration, such costs to be taxed on the indemnity basis unless agreed with the Trustee's Agents. .
