ORDER

UPON the applications of Partners Group Access Secondary 2008, L.P., Partners Group Access 89, L.P., Partners Group Maple Leaf Secondary Fund II, L.P. Inc., Partners Group Access IV L.P. and Partners Group Global Value SICAV (the "**Petitioners**") by their Summons for Directions dated 4 June 2013 ("**Summons for Directions**") and their Summons dated 4 June 2013 seeking the appointment of joint provisional liquidators ("**PL Summons**")

AND UPON hearing Counsel for the Petitioners, Counsel for Cybernaut Capital Management Limited (the "**General Partner**") and Counsel for Oriental Financial Holding Corporation ("**Oriental**")

AND UPON the General Partner and Oriental's oral application for an adjournment of the PL Summons

AND WITHOUT PREJUDICE to the rights of the General Partner and Oriental to apply for a stay under section 9 of the Arbitration Law, 2012 or dismissal of the Petition and/or the PL Summons

IT IS ORDERED BY CONSENT that:

- 1 On the Summons for Directions, pursuant to CWR O.3, r.12:

1.1 Cybernaut Growth Fund, L.P. (the "**Partnership**") shall not participate in the proceedings which shall be treated as proceedings between the Petitioners, and the General Partner and Oriental; and

1.2 The Petition be heard without the need for prior advertisement.

2 The PL Summons be adjourned generally.

3 Any application by the General Partner and/or Oriental to stay the petition shall be filed by 20 June 2013.

4 The parties shall have liberty to apply.

5 The costs of and incidental to the hearing on 11 June 2013 shall be costs in the Cause.


