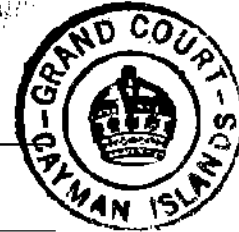

  - 1.2 Paragraph 4.2 is varied to extend the time for the Petitioners to file and serve any evidence in reply to 2 August 2013.
2. Save as provided in paragraphs 1.1 and 1.2 above there will be no further exchange of evidence without the agreement of the parties or by order of the Court.
3. This Consent Order be made without prejudice to paragraph 1 of the Order of the Honourable Mr Justice Jones dated 25 June 2013.
