UPON the application of KBC Investments Cayman Islands V Limited (the "Petitioner") by its Summons post dated 1 August 2013 seeking leave to withdraw the Petition dated 10 July 2013 ("Petition") and the application of Aramid Entertainment Fund Limited (the "Company") by its Summons dated 25 July 2013 (the "Validation Summons") seeking orders for the validation of Fund expenses

AND UPON reading the First Affidavit of Jatin Tosar dated 3 July 2013, the Amended First Affidavit of Roger Hanson dated 30 July 2013, the First Affidavit of Omid Zareh dated 24 July 2013 and Second Affidavit of Roger Hanson dated 25 July 2013

**IT IS ORDERED AND DIRECTED THAT:**

1. Leave is granted to the Petitioner pursuant to the Companies Winding Up Rules 2008 (as amended) Order 3, rule 7 to withdraw the Petition dated 10th July 2013.
2. The liability, if any, for costs consequent upon the said withdrawal shall be determined at a hearing on Tuesday, 15th August 2013 at 10:00am in Chambers.
3. The Petitioner shall serve any affidavit evidence in support of its application concerning costs no later than noon on Tuesday, 6th August 2013 and shall at the same time deliver to the Company's attorneys and to the secretary to the assigned judge the hearing bundle, any authorities, its skeleton argument and a draft proposed order.

4. The Company shall serve any affidavit evidence in reply to the Petitioner's evidence no later than noon on Monday, 12th July 2013 and at the same time deliver its skeleton argument.
5. There be no order on the Validation Summons.
