IT IS ORDERED that:


- 1 the JOLs be granted sanction, retrospectively, of the following actions:
 - 1.1 The commencement and conduct of legal proceedings, in the name of and on behalf of the Company, against Maxi Harvest Limited, filed in the Taipei District Court of Taiwan in April 1999;
 - 1.2 The compromise of a potential claim against Samyang Merchant Bank on 23 April 1999;
 - 1.3 The execution and completion of a settlement agreement with PIV Services Sdn Bhd dated 18 June 2008;
 - 1.4 The defence of legal proceedings, in the name of and on behalf of the Company, filed by Sweet Bygones Limited in the Taipei District Court of Taiwan in March 1998;

1.5 The sale of US\$19 million worth of listed shares held by the Company between March 1998 and August 2000.
