IT IS ORDERED BY CONSENT that:

1. The Plaintiff do within 7 days of the date of this order pay into Court the sum of US\$69,000 by way of security for the Fourth Defendant's costs of these proceedings;

AND UPON READING the First Affidavit of Laura Accurso and the First Affidavit of James Webster and the respective exhibits thereto and the further documents submitted at the hearing on 25th November 2013;

AND UPON HEARING Counsel for the Plaintiff and Counsel for the Fourth Defendant;

IT IS FURTHER ORDERED that:

2. The Plaintiff do by 3pm on 16 December 2013 secure to the reasonable satisfaction of the Fourth Defendant, failing which pay into Court:

- a. the further sum of US\$24,916,567 ordered to be paid to the Fourth Defendant by the Plaintiff pursuant to the Third Order of the Arbitration Panel dated 15 August 2013;
 - b. the further sum of US\$210,150.16 ordered to be paid to the Fourth Defendant by the Plaintiff pursuant to the Fourth Order of said the Panel dated 7 October 2013.
3. The costs of the application be in the cause.
