ORDER




UPON hearing the Summons issued by the Joint Official Liquidators of Focus Management Inc (in Official Liquidation) ("Company") dated 25th November 2013
AND UPON reading the Sixth Affidavit of Hugh Dickson sworn on 25th November 2013
AND UPON hearing Counsel for the Joint Official Liquidators
IT IS ORDERED THAT:

1. the payment out of the assets of the Company of the fees and expenses of the Joint Official Liquidators incurred between 1 January 2013 and 30 June 2013 in the sum of US\$77,390.50 and US\$1,626.11 for the remuneration and disbursements respectively of Grant Thornton Specialist Services (Cayman) Limited and CAD\$7,087.50 for the remuneration of Raymond Chabot Grant Thornton is approved pursuant to section 109 of the Companies Law (as revised) and the Insolvency Practitioners Regulations 2008 (as amended);

2. The hourly rates in Canadian dollars charged by Raymond Chabot Grant Thornton in Montreal as set out in the schedule to the Liquidators' remuneration report dated 17 July 2013 are approved in so far as may be necessary pursuant to Regulation 15 of the Insolvency Practitioners Regulations 2008 (as amended);
3. the Liquidators have sanction pursuant to section 110(2)(a) and Schedule 3 of the Companies Law (2013 Revision) for the issue of a writ of summons in the Supreme Court of the Commonwealth of The Bahamas in the form exhibited at tab 7 of exhibit HD6 to the Sixth Affidavit of Hugh Dickson;
4. the Joint Official Liquidators are directed to file in Court an updated report setting out the status of the liquidation of the Company as at 31st March 2014 and to apply for the approval of their fees and expenses as soon as reasonably practicable thereafter;
5. The Joint Official Liquidators be entitled to their costs of and occasioned by this application to be paid out of the assets of the Company.
