ORDER

UPON hearing counsel for, Kenneth Krys and Margot MacInnis of KRyS Global in their capacities as Trustee's Agents in respect of the bankrupt estates of Patricia H. Millard and William H. Millard (FSD #s 60 and 61 of 2013) ("the Debtors' Estates" and "the Bankruptcy Proceedings") and as Joint Official Liquidators of the Companies in respect of their Summonses dated 25 November 2013;

AND UPON hearing Counsel for the Government of the Commonwealth of the Mariana Islands;

AND UPON reading the First Affidavit of Kenneth Krys sworn on 22 November 2013;


AND UPON reading the Order for Directions made in the Bankruptcy Proceedings on 10th December 2013;

IT IS ORDERED that:

1. The JOLs shall not establish liquidation committees in respect of any of the Companies.
2. The JOLs shall not convene any meetings (in accordance with CWR Order 8, rule 2) unless directed to do so by the Court.
3. The preparation and filing of consolidated reports and accounts in accordance with paragraph 1 of the Order for Directions made in the Bankruptcy Proceedings shall be treated as compliance with the JOLs reporting and accounting obligation in respect of the Companies under CWR Order 10.
4. The JOLs shall make applications to the Court for approval of their remuneration in their capacities as official liquidators of the Companies and Trustee's Agents in respect of the Debtors' Estates on a consolidated basis for the period ended on 31 December 2013, such application to be heard on 14 February 2014.
