

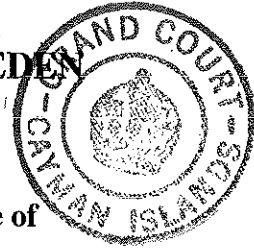

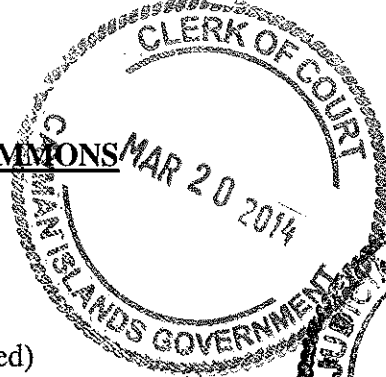

Within [14 days] after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the

Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

### **INDORSEMENT**

The Plaintiffs claim as lawful children of Wilber Ravenel McLaughlin Sr., deceased, late of 25 William James Watler Road, Gun Bay, East End, Grand Cayman, Cayman Islands, who died on the 1<sup>st</sup> day of July 2012 to have his alleged will, dated 17 October 2009 pronounced against by the Court on the grounds that the said Wilber Ravenel McLaughlin alleged will was not signed or acknowledged by him, the deceased, in the presence of two witnesses present at the same time. 
